- **Fun Run Funds:** Mrs. Tracy wanted to discuss allocation of Fun Run funds. \$9,000.00 is going to assemblies for this school year. \$15,000.00 was approved for the library.
- Halloween: Mrs. Scanlon explained that it is the District's policy that Halloween is not celebrated within the schools because there are families who do not celebrate this holiday.

- **Courtyard Shed:** Mr. Costa shared that he will be building the foundation on November 16th for the shed. He is also looking for someone to build the recess shed.
- **Spirit Wear:** Mrs. Tracy updated us that Store Front will be doing our spirit wear. Flyers will be coming out soon and orders can be placed online.
- **Yearbook:** Mrs. Grover made an announcement that they are collecting pictures throughout the years for the year book. They will be placing an announcement on the Association's Facebook page.
- Art Night: Art Night will be held in April, before vacation.
